# President's Message

With this report we look back on another academic year of achievements and landmarks for St. Thomas More College. We began work on a new strategic plan and reached out to more stakeholders than ever before for their input. We began revising our Catholic mission and identity statement to reflect the College as it is in the era of Pope Francis. Our faculty and staff completed the final year of the Indigenous Voices program, which promises to produce a new narrative for a more culturally inclusive STM. We had exceptionally strong enrolment, with more than 5000 students taking STM classes. Our faculty received awards for teaching excellence as well as new grants to support research. Our Just Youth student group received the YMCA Peace Medal for their volunteer work in peace-building. And STM continued to provide a forum for illuminating presentations on the role of the liberal arts and faith in society today, such as those by Dr. Angus Reid and Fr. James Heft.

Over more than 80 years as a federated college at the University of Saskatchewan, STM has changed considerably as a community but it continues to pursue the same mission that inspired its creation. We seek to provide a transformative education in the Catholic intellectual tradition for young people who will become leaders and agents of change in the world.

In an increasingly unpredictable world, where technological innovation affects every aspect of our lives, a liberal arts education that insists on integrating knowledge from many spheres of inquiry is more valuable than ever. The exposure to multiple perspectives fosters mental flexibility and resilience, exactly the kind of resourcefulness required to adapt to rapid and dramatic change.

Time and again we see that those who make the most of their learning experience at STM, in the classroom and beyond, become successful professionals and leaders in their fields. They live out the STM mission even more fully when they strive to bring about a society that respects human dignity and promotes human flourishing for all its members.

In the annual report that follows you will see vivid illustrations of STM's mission in action. In stating our mission we assert three fundamental things: that reason and faith are ultimately compatible and can be harmonized to achieve a fuller grasp of truth; that the fruits of our labours in the academy must be shared with others as an act of service; and that our community is open to all who wish to join in our work. At a time when some think that religion has no valid place in the public sphere, when the accumulation of wealth has set a privileged few apart from most others, and when some are more tempted to build walls than bridges, the mission of STM remains more relevant, transformative, and life-giving than ever.

## CATHOLIC IDENTITY STATEMENT REVIEW

## **CAMPUS MINISTRY**

St. Thomas More College's first Catholic Identity and Mission Statement was adopted in 2012. At the time, the document was described by Interim President Ken Smith as "representing a consensus of conviction by our community recognizing that we strive for unity amidst our diversity". This living document serves as a tool to facilitate and stimulate discussion about our core identity as a Catholic College federated with the University of Saskatchewan.

In 2018, we began a process to review this document, with the goal of bringing our sense of identity and purpose into dialogue with the issues and concerns facing us as a College today. A working group made up of faculty, staff, and administration continue this review and will initiate wide consultation on the revised statement in the new year. Campus Ministry continues to be a catalyst of our Catholic identity and mission at STM. In 2018-2019, the team consisted of Mr. Michael MacLean, Fr. André Lalach, and Dr. Gertrude Rompré (Director), with the support of Fr. Ron Griffin, CSB, and Fr. Mark Blom, OMI.

STM Campus Ministry underwent a thorough review of its programming and staffing needs during the year, recommitting itself to providing a wide array of programs and supports following the Comprehensive Campus Ministry Model.

Some highlights of the team's work included re-instituting the Montreal Memorial and playing an active role on the University of Saskatchewan's Faith Leaders' Council. Alongside their regular programming, STM Campus Ministry provides pastoral support and spiritual direction to STM students, faculty and staff.

## INDIGENOUS ENGAGEMENT

STM continues to respond to the Truth and Reconciliation Commission's Calls to Action under the guidance of its Advisory Circle on Indigenous Spirituality and Reconciliation. Some key initiatives were:

Staff, faculty and leadership participation in the Indigenous Voices program
Meeting with and reporting to Ms. Jennifer Brass, Senior Indigenous Advisor,
Saskatchewan Ministry of Advanced Education

• Participating in both the University of Saskatchewan's and Universities Canada's Building Reconciliation events

• Ongoing participation in campus-wide Dialogues on Reconciliation by members of the leadership team

• Participating and volunteering at the Walking with Our Sisters closing ceremonies at Batoche

Volunteering and supporting the USask Graduation Powwow

This, by no means exhaustive list, highlights the work, and heartfelt commitment to reconciliation, undertaken by our faculty and staff.

In conclusion, I am grateful to our students, staff, faculty, and friends, for their ongoing support of STM's unique identity and mission. In the words of St. Paul, "we have this treasure in clay jars, so that it may be made clear that this extraordinary power belongs to God and does not come from us" (2 Corinthians 4. 7). ## **STM FACULTY MILESTONES**

• Tenure and Promotion: Cynthia Wallace, English, and Monica Hwang, Sociology, were granted both tenure and promotion to the rank of Associate Professor.

• New Hires: Kylee-Anne Hingston was hired as an Assistant Professor in the Department of English; Henri Biahé was hired into the Department of Languages, Literature, and Cultural Studies as an Assistant Professor.

## RETIREMENTS

• Dr. Darlene Kelly, Department of English, retired this year after more than thirty years of service to the College.

## NEW ACADEMIC INITIATIVES

• The Faculty Council of the College of Arts and Science formally renamed the Department of Linguistics and Religious Studies to just Department of Linguistics. The University's Department of Religious Studies (Religion and Culture, officially) is now managed through STM.

 New courses in Dene Culture, another in Peace Studies, and capstone courses for potential certificate programs in Catholic Studies and Critical Perspectives on Social Justice and the Common Good, were being designed. Further initiatives, such as programs in Labour Studies and Politics, Philosophy, and Economics, are also being discussed.

## Strategic Plan 2020-25

The College began the process of developing a new strategic plan for the years 2020-25 and formed a Steering Committee, consisting of members from administration, faculty, and staff ranks. A student representative has also been added. Academica Group, a well-known firm that works in the field of post secondary education in Canada, is hired to help with the development and facilitation of the plan.



# **Enhancing the Student Experience**

Report of the Associate Dean, Dr. Tammy Marche

## **COMMUNITY SERVICE-LEARNING OPPORTUNITIES**

• 244 students participated in Community Service-Learning across 20 STM classes. They volunteered with nineteen local community partners, including Frontier College, Hands on Ministries, Micah Mission, Saskatoon Open Door Society, and Samaritan Place. New partners this year include SaskAbilities, St. Ann's Senior Citizens Village, and Central Haven Special Care Home.

• STM students had the opportunity to participate in community-engaged research. Students in one of our psychology classes worked as volunteers at Luther Communities on a project to help seniors connect with family and friends on social media and examine how socializing online improves the wellbeing of older adults. Students in one of our English classes, which focuses on the culture of disability, partnered with L'Arche Saskatoon and Sherbrooke Community Centre.

## **RESEARCH EXPERIENCE**

• STM entered a three-year agreement with the University of Saskatchewan to offer First Year Research Experience (FYRE) courses. These courses offer first year students the opportunity to engage in academic research with the guidance of their professor and research coaches. FYRE had been offered on an ad hoc basis in Economics and CMRS the year prior.

## **EDUCATION ABROAD**

• In May and June, students traveled to Ternopil, Ukraine for the 5-week STM Spring Session in Ukraine. Fully immersed in Western Ukrainian culture, students from a variety of academic and professional backgrounds learned about the history and contemporary reality of Ukraine while enhancing their spoken and written skills in the Slavic language.

## **EXTRA-CURRICULAR OPPORTUNITIES**

• STM partnered with Canadian Roots Exchange to facilitate community-building exercises that teach students about issues affecting Indigenous peoples, both locally and nationally. Students were provided with financial assistance to attend the national conference, which was held on the University of Saskatchewan campus.

• Financial support was provided to students so that they could attend the Mennonite Central Committee Student Seminar in Ottawa in February 2019. Over the three-day conference, student leaders learned about human rights, the root causes of global migration, and heard from parliamentarians and civil society advocates who are working towards addressing these complex issues.

• The Service and Justice Project, which introduces students to notions of charity and justice through the lens of Catholic social teaching, paired students with local organizations so that they could serve marginalized communities in the city. Regular meetings allow students the opportunity to reflect on their own experience in light of social issues.

• Our 8 student organizations participated in and/or planned a number of events and activities. For example, STMSU presented the John Thompson Lecture in March where Dr. Sharon Wright spoke on the legitimacy and power of gender fluidity in medieval thought. STM Just Youth participated in the national Development and Peace #sharethejourney campaign to educate and act on the issue of forced human migration. This included hosting a Walk for Freedom event in support of refugees in October. STM Newman Sounds and the Newman Players also entertained the college and community with their music and drama performances.

## ENHANCEMENTS IN STUDENT SUPPORTS AND SERVICES

• A new academic advising assessment process was implemented to ensure quality in the advising we provide to students and to serve as a guide for faculty members who provide academic support. Staff also received additional educational training in academic advising. As well, a new online booking system for academic advising appointments was implemented.

 An Education Abroad policy and procedures document was developed, which will make STM's education abroad programs safe, sustainable, and based on ethical partnerships.

• STM's Mental Health and Wellness Committee, currently composed of the Associate Dean, Manager of Human Resources, and the Director of Mission and Ministry, was formally established. One of its goals is to create a means by which students, as well as staff and faculty, can access resource information and services related to mental health and wellness. We continue to ensure that staff who provide front-line service to students are trained in Mental Health First Aid.

 Both the Student Services and Engaged Learning Offices each created departmental mission and values statement to illustrate how their work aligns with the wider mission of the College. This exercise helped the teams reflect on how their services incarnate the Catholic identity of the College as a whole.

Approximately \$185,000 in financial support was available last year for STM undergraduate students.

## Advancing Awareness Report of the Director of Communications, Marketing and Student Recruitment

Advancing community/student awareness of the College through marketing and recruitment initiatives remains a priority, with an end goal to support enrollment retention and growth. Maintaining strategic promotion through a varied media mix in 2018-2019 effectively kept STM's name/brand visible among USask postsecondary education (PSE) options along with clarity as to our inclusivity, offerings and achievements.

Marketing and recruitment initiatives were impactful in contributing to a third straight year increase in student numbers and course registrations through STM. 2018-2019 had the highest registration level in the past six years, with 5,500 students. This was a growth of 580 more students over the previous year.

# **Development and Alumni Relations**

Report of the Director of Development Karen Massett

2018 - 2019 proved a busy and challenging year for the Development Office. A variety of initiatives were undertaken to advance the Strategic Plan and although donation totals were lower than the previous year, significant funding was raised for STM student awards. 2018 was particularly demanding with the additional planning and orchestration of the President's Gala co-chaired by the Director of Development and the Director of Marketing and Communications, a small but mighty committee of two. This event was held in June to raise funds for STM student scholarships and bursaries.

A new part-time Development Assistant position was established in November 2018 to address the workload and assist with efficiencies in the Development Office.

## STUDENT SUPPORT

A major goal for the Development Office is to improve the student experience by securing funding for student scholarships and bursaries which help to alleviate financial barriers. Examples of funds raised in 2018-2019 which were directed to student scholarships, bursaries and programs include:

• \$35,500 President's Gala June 2018

- \$3,000 Henry Remai Emergency Student Bursary
- \$32,850 McNeill Hunt Endowed Bursary
- \$1,500 Ted and Danielle Fortosky Bursary Fund
- Bursary \$1,250 Basilian Scholar Award
- \$19,825 Direct Appeals –STM Scholarship and Bursary Fund .
   \$20,000 John and Elizabeth Kaufmann Scholarship
  - \$5,950 Community Service-Learning Programs
  - $\cdot$  \$3000 Ukrainian Self-Reliance -Ukrainian Language Award

The Scholarship Awards ceremony was celebrated in November and the Bursary Awards ceremony in January. STM donors were invited to present their awards to grateful student recipients. A reception followed in the STM cafeteria, where students and their family members enjoyed the opportunity to visit with donors and express their appreciation.

## INDIGENOUS ENGAGEMENT

STM Development fosters support for Indigenous communities and students through increased donations for Indigenous student awards and the Basilian Chair in Indigenous Spirituality and Reconciliation. In 2018-2019, targeted support was achieved through donor solicitation, appeals in *More news*, and the Christmas appeal. Funds raised included \$9,500 for Indigenous student bursaries and \$4,100 for the Basilian Chair in Indigenous Spirituality and Reconciliation.

The STMNAA worked to strengthen the connection between STM Alumni and their alma mater. Highlights of the year included:

# Sustainable Resources

**Report of the Chief Financial Officer and Director of Administration** Derrin Raffey

2018-2019 saw several positive developments for STM financially, however, rising costs and other constraints kept attention focussed on some concerns going forward. Enrolment was over 9,000 three-credit unit courses, however the provincial government budget of 2018-2019 saw a 0% increase to provincial operating grants for all federated colleges, with similar grant levels for provincial universities.

## **ENROLMENT**

STM experienced a significant increase in enrolment for the 2018-2019 academic year, continuing a College enrolment trend that saw growth every year for the past 4 years.



Pressure on government coffers due to decreased revenues from resources resulted in a 0% increase to the government operating and capital grants for 2018-2019.



## **OPERATING EXPENDITURES**

As part of our commitment to running an efficient and effective post-secondary institution, we are constantly looking for areas where we can utilize our resources more efficiently while maintaining our service levels to students. In return for their tuition investment, students expect funds to be well-managed just like all taxpayers expect their funds to be used through government grants.



## DONATIONS

Donations were lower in 2018-2019 than in prior years. Apart from a large one-time donation in 2017-2018, donation receipts have generally been on a downward trend for the past 5 years.



## **INVESTMENT RETURNS**

STM's investment returns were slightly higher than the prior year returns at 4.95% for the fiscal year, however the overall investment balance declined due to the liquidation of approximately \$1M in investments to cover short term cash requirements.





#### **PHYSICAL PLANT**

As part of becoming more energy efficient in the College, STM completed several initiatives in 2018-2019 that will result in less overall energy being used in the College. Several windows that were over 50 years old were replaced with new energy efficient models. Additionally, plans were made to replace the last of the legacy chillers in the building and all chillers will now be high efficient units, that will cut down on utility usage moving forward.
